Ways to Give:

1 Bequests – a charitable gift in your Will

A bequest is a gift in your Will that can be changed or modified at any time. You can choose to designate that your bequest be used for general use, or perhaps for a specific purpose that is within Hope Air's mandate thereby providing you with the peace of mind knowing that your gift will be used as intended. Bequests are also a meaningful way to reduce estate taxes while supporting Hope Air.

There are a number of ways you can make a bequest to Hope Air:

- 1. Specific Bequest:** A specific bequest involves making a gift of a specific dollar amount from your estate.
- 2. Percentage Bequest:** We know that your family comes first and you'll want to ensure they are supported. Choosing to give a percentage of the residual of your estate means that after your family is taken care of a designated portion of your remaining assets would be gifted to Hope Air.
- 3. Residual Bequest:** This form of a bequest is made from the remainder of your estate after all your other provisions have been made. Most common forms of a residual bequest involve leaving a percentage of the residue of your estate to a charity.
- 4. Contingent Bequest:** You could choose to leave specific property, such as a vacation home for example, to a relative or friend, but the bequest language could provide that if this relative is not alive at the time of your death, then the vacation home will go to the charity of your choice.

2 Gift of Life Insurance

Through your life insurance you can leave a larger gift than is possible for most people during their lifetime. When you name Hope Air as a beneficiary and/or owner of your life insurance policy, you could benefit from tax savings in your lifetime or tax savings for your estate.

Appendix A: Suggested Wording

The following are sample clauses only. A lawyer or estate planner should review any wording.

Specific, unrestricted:

I give, devise and bequeath to Hope Air the sum of \$_____ to be used for any purpose(s) approved by the Board of Directors of Hope Air.

Specific, restricted with escape clause:

I give, devise and bequeath to Hope Air the sum of \$_____ to be used for the following purpose(s): _____. If Hope Air is unable to apply all or part of these funds for the specific purpose(s) stated herein, the balance of this bequest not so extended may be used for any purpose approved by the Board of Directors of Hope Air.

General % unrestricted:

I give, devise and bequeath to Hope Air ____% of the residue of my estate to be used for any purpose(s) approved by the Board of Directors of Hope Air.

Residual contingent trust:

Upon the death of the survivor of my (wife, husband, etc.) _____ and my (son, daughter, etc.) _____, I direct my trustee to transfer and deliver the balance of the residue of my Estate, including any undistributed income to, Hope Air to be used for any purpose(s) approved by the Board of Directors of Hope Air.
